As billed and approved by the Court, not to exceed \$100 per hour without prior approval of the Court.

Expenses of Investigation:

At amount incurred, as approved by the Court (Other than Investigator)

Investigators and experts to submit such documentation as Court requires.

**CORYELL COUNTY SCHEDULE OF FEES FOR COURT APPOINTED ATTORNEYS
FOR JUVENILE MATTERS**

Attorneys appointed to represent a juvenile in proceedings in which an adjudication of delinquent conduct, determinate sentencing, or transfer to a felony court after approval of petition by the Grand Jury shall be paid in accordance with the provisions herein for the payment of attorneys appointed in non-capital felony cases.

Attorneys appointed to represent a juvenile alleged to be a child in need of supervision or in all other juvenile matters not described in the preceding paragraph shall be paid in accordance with the provisions herein for the payment of attorneys appointed in misdemeanor cases.
